Pursuant to Article 70, paragraphs (1) and (3) of the Public Procurement Law (Official Gazette of BiH, 39/14), in connection with the provisions of the Rulebook on the procedure for awarding the contract for services referred to in Annex II, Part B of the Public Procurement Law (Official Gazette of BiH, No. 66/16), Article 49, paragraph (2) of the Central Bank of Bosnia and Herzegovina By-Law, Number: UV-104-01-1-116 / 15 as of 28 December 2015 and Article 13, paragraph (2) of the Public Procurement By – Law, Number: UV-122-01-1-11/18 RJ of 30 January 2018, the Governing Board of the Central Bank of Bosnia and Herzegovina at the 9th session as of 30 July 2019 delivered

the DECISION

on the selection of the most favorable bidder in the public procurement procedure of services: production of coins - denomination of 2 KM

Article 1

- (1) The Central Bank of Bosnia and Herzegovina (hereinafter: the Central Bank) awards a contract for the procurement of services of coin production denomination of 2 KM to the bidder: The Royal Mint Limited, United Kingdom.
- (2) The public procurement procedure referred to in paragraph (1) of this Article is carried out pursuant to the Rulebook on the procedure for awarding the contract for services referred to in Annex II, Part B of the Public Procurement Law (Official Gazette of BiH, 66/16).

Article 2

(1) Bidder's bid referred to in Article 1 of this Decision shall be the amount of

448 600,00 EUR

(in letters: four hundred fourty eight thousand six hundred EUR and 00/100)

(2) Herein we put in charge the Banking Department of the Head Office of the Central Bank of Bosnia and Herzegovina to pay out the provider, to the account indicated on the invoice, in accordance with the terms of the contract to be concluded on the basis of the Public Procurement Law.

Article 3

Upon meeting the conditions for concluding the contract on the basis of the Public Procurement Law, the Central Bank shall conclude the contract with the selected bidder referred to in Article 1 of this Decision, for which the Cash Management Department of the Head Office of the Central Bank of Bosnia and Herzegovina is herein made responsible.

Article 4

The Central Bank shall notify the bidder on the results of the public procurement-procedure.

Article 5

For the implementation of this Decision, the Department of Accounting and Finance and the Public Procurement Department of the Head Office of the Central Bank of Bosnia and Herzegovina are herein put in charge.

Article 6

This Decision will be published on the website of the Central Bank: www.cbbh.ba at the same time when being sent to the bidder who participated in the public procurement procedure in accordance with Article 70, paragraph 6 of the Public Procurement Law ("Official Gazette of BiH", 39/14).

Explanation

The public procurement procedure of services of coins production - denomination of 2 KM, was initiated by the Decision, Number: 150-07-1-1159-2 / 19 ŽB, dated April 5, 2019.

Pursuant to Article 8, paragraph (1) of the Public Procurement Law (Official Gazette of BiH, 39/14) and Article 7, paragraphs (3) and (4) of the Rules on the procedure for awarding the contract for services from the Annex II, Part B Public Procurement Law, the Central Bank published the Invitation to Bid for the first phase. i.e. pre-qualification phase, Number: 150-07-1-1159-5 / 19 on the website: www.cbbh.ba and sent it to three addresses, on May 17, 2019.

Within the deadline for submission of bids, one bid was submitted in a timely manner from the bidder: The Royal Mint Limited, United Kingdom.

The Commission responsible for carrying out the public procurement procedure has reviewed and evaluated the received bid and concluded that the received bid has met all the qualification requirements, required in the aforementioned Invitation, and it recommended to access the second phase of the procedure, with the aforementioned bidder in the Minutes on Review and Evaluation of Documents, No. 149-07-1-1577-4 / 19. dated June 7, 2019.

In accordance with the recommendation of the Commission, the Public Procurement Department prepared an Invitation to submit bids for the second phase - the phase of submission of initial bids and negotiations. Number: 150-07-1-1159-9 / 19, dated 12 June 2019, and delivered it to qualified Bidder from the first phase of the procedure.

A qualified Bidder from the first phase of the procedure submitted its bid, within the deadline for submission of bids.

On 5 July 2019, the Commission reviewed the submitted bid and concluded that the bidder had submitted all required documents for participation in the second phase of the procedure.

The above-mentioned Invitation for the second phase of the procedure envisages the negotiations with the Bidder to be held on July 5, 2019, in the premises of the Central Bank of Bosnia and Herzegovina in Sarajevo. Also, the Invitation provides that if the authorized representative of the Bidder does not appear at the negotiations, the Central Bank shall consider that the Bidder will remain at the price from the submitted bid. Considering that the Bidder informed the Central Bank in writing that its authorized representative was not able to attend the negotiations in the time schedule set by the Central Bank, the Commission made a recommendation as in the introductory of the Decision, in the Minutes on review and evaluation of Bid, No. 149-07-1-1577-6 /19 and in the Report on its work with recommendation, No: 149-07-1-1577-7/19, both from July 5, 2019.

Legal remedy:

Against this Decision, a written appeal may be lodged with the Central Bank of Bosnia and Herzegovina within ten days from the date of delivery of this Decision.
