On the basis of Article 70 paragraph (5) of the Public Procurement Law (Official Gazette BH, 39/14), Article 50 paragraph (1) of the By-law of the Central Bank of Bosnia and Herzegovina, ref: UV-104-01-1-116/15 dated 28 December 2015 and Article 13 paragraph (2) item c) of the By-law on Public Procurements, ref: UV-150-01-1-1467-3/20 dated 27 July 2020, the Governor of the Central Bank of Bosnia and Herzegovina has passed the

DECISION

on prequalification result in the process of public procurement of the services of using the tools for the production of the banknotes in 200 KM denomination and providing technical information on security features for which there is intellectual property of OEBS

Article 1

The Bidder OEBS Vienna, Republic of Austria, is qualified to participate in the second stage of the process of the public procurement of the services of using the tools for the production of the banknotes in 200 KM denomination and providing technical information on security features for which there is intellectual property of OEBS.

Article 2

The Commission responsible for conducting this public procurement procedure is instructed to conduct the second phase - the procedure of negotiations with the bidder referred to in Article 1 of this Decision.

Article 3

The Central Bank of Bosnia and Herzegovina will inform the Bidder on the prequalification result.

Explanation

The process of the public procurement of the services of using the tools for the production of the banknotes in 200 KM denomination and providing technical information on security features for which there is intellectual property of OEBS, by negotiation process without announcing a notice on procurement, has been started by Decision ref: 150-15-4-134-2/21 SAK dated 12 January 2021.

Accordingly, on 25 February 2021, the Central Bank sent an Invitation to participate in the negotiation process without announcing a notice on procurement, to the Bidder referred to in Article 1 of this Decision.

Within the deadline for submission of bids, the aforementioned Bidder submitted the initial bid. The Commission, responsible for conducting the public procurement procedure, reviewed and evaluated the bid and concluded that the received bid meets all the conditions required by the tender documentation.

The Commission issued a recommendation in the Minutes on the Review of Documentation, number: 149-07-1-924-4/21 dated 29 March 2021, as said in the enacting clause.
